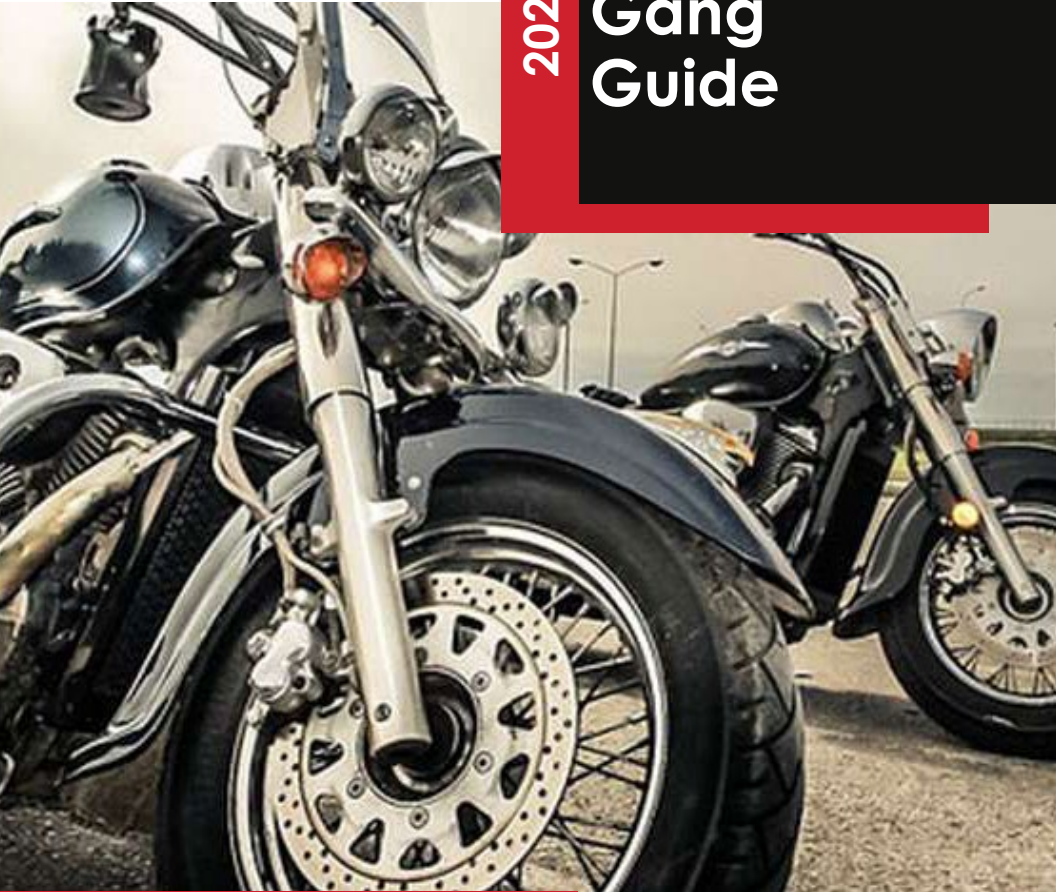

Outlaw Motorcycle Gang Guide

PURPOSE



(U) The National Gang Intelligence Center (NGIC) and the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) assess there are approximately 300 Outlaw Motorcycle Gangs (OMGs) in the United States. OMGs range in size from a single chapter, to multiple chapters in several states, to hundreds of chapters worldwide. Every year new OMGs are created, smaller ones merge, and weaker ones disband. For the purpose of this guide, only prevalent US-based OMGs are featured. Due to the fluid, ever-changing biker environment, this guide does not list known clubhouses, but does list known locations or states for each OMG. The NGIC and the International Outlaw Motorcycle Gang Investigators Association (IOMGIA) recommend contacting individual state or local law enforcement agencies directly for specific details regarding OMG size or activities in a particular jurisdiction.

(U) The NGIC created this product in cooperation with IOMGIA and law enforcement partners across the United States. The information contained herein represents a compilation of information available to the NGIC and is intended for law enforcement use only.

OMG DEFINITIONS AND TERMINOLOGY

OMG and gang definitions vary between states and even between federal agencies. The NGIC conforms to the US Department of Justice definition of gangs:

(1) an association of three or more individuals;

(2) whose members collectively identify themselves by adopting a group identity which they use to create an atmosphere of fear or intimidation frequently by employing one or more of the following: a common name, slogan, identifying sign, symbol, tattoo or other physical marking, style or color of clothing, hairstyle, hand sign or graffiti

(3) the association's purpose, in part, is to engage in criminal activity and the association uses violence or intimidation to further its criminal objectives

(4) its members engage in criminal activity, or acts of juvenile delinquency that if committed by an adult would be crimes

(5) with the intent to enhance or preserve the association's power, reputation, or economic resources

(6) the association may also possess some of the following characteristics: (a) the members employ rules for joining and operating within the association; (b) the members meet on a recurring basis; (c) the association provides physical protection of its members from other criminals and gangs; (d) the association seeks to exercise control over a particular location or region, or it may simply defend its perceived interests against rivals; or (e) the association has an identifiable structure

(7) this definition is not intended to include traditional organized crime groups such as La Cosa Nostra, groups that fall within the Department's definition of "international organized crime," drug trafficking organizations or terrorist organizations

IOMGIA has adopted the National Crime Information Center's gang criterion for defining OMGs and their members; with the understanding that owning and operating a motorcycle is paramount for membership.

NCIC GANG DEFINITION



A. Must be an ongoing organization, association, or group of three or more persons and

B. The group must have a common interest and/or activity characterized by the commission of or involvement in a pattern of criminal or delinquent conduct. These acts are defined as: narcotics distribution, firearms or explosives violations, murder, extortion, obstruction of justice (including witness intimidation and/or tampering), and any other violent crimes such as assault, threats, burglary, carjacking. Delinquent conduct is the conduct of a juvenile which would be a crime if committed by an adult. Criminal conduct includes acts committed while incarcerated.

NCIC GANG MEMBER DEFINITION



An individual who meets any two of the following criteria:

1. Self-admission at the time of arrest or incarceration, or 2. Any two of the following criteria:

A. Identified as a gang member by a reliable informant;

B. Identified as a gang member by an informant whose information has been corroborated;

C. Frequents a gang's area, associates with known members, and/or affects gang dress, tattoos, or hand signals;

D. Has been arrested multiple times with known gang members for offenses consistent with gang activity; or

E. Self-admission (other than at the time of arrest or incarceration).



ONE PERCENTERS (1%ERS)

(U//LES) OMG members are also referred to as One Percenters. The term was born at the 1947 Hollister, California Motorcycle Rally where after an evening of drunken debauchery an American Motorcycle Association statement claimed that 99% of the rally attendees were law abiding citizens; thus the other one percent of attendees were outlaws. Since then, a 1% symbol in a diamond shaped patch has become a common icon of many OMGs, but not all OMGs mandate that their members wear a one percent diamond patch.

LEADERSHIP STRUCTURE

(U//LES) Most OMGs have national officers normally consisting of a president, vice president, secretary, treasurer and sergeant at arms. This leadership structure is also consistent with the local chapter leadership structure as well. Some OMGs may also have an enforcer or road captain within their leadership structures.

PATCHED MEMBER

(U//LES) Full-fledged member of the organization and has rights and privileges associated with membership. Patched members may hold office or leadership positions within the organization as well.

PROSPECT

(U//LES) Sometimes called Probationary member, the prospect is an individual who desires membership in the organization. The prospect is presented, or sponsored by a patched member, and will wear modified club patches that indicate his prospective status. During the prospect phase, the prospect will perform work or duties for the club and its patched members. Some of this work may be criminal in nature. The prospect is evaluated during the prospect phase, sometimes lasting up to year, to determine suitability within the organization. During the prospect phase, the prospect has no status or influence on the organization's business.





HANG-AROUND/ASSOCIATE

(U//LES) Hang-arounds or associates of the organization are individuals who the organization has accepted their presence at their clubhouse or functions, and may aspire to become prospects and patched



PROPERTY OF

(U//LES) Some OMGs issue or allow the wives or girlfriends of patched members to wear a vest or other clothing indicating that she belongs to a particular member. Women wearing this will also have no say or status within the organization.

IDENTIFIERS

(U//LES) The most common and easily recognizable way to identify OMG members is through the patches they wear on leather or denim vests. These patched vests are called colors, and are sometimes called rags or cuts depending on where they are from in the United States. Generally, most OMGs wear a three-piece patch set on the back of their vests, which is the foundation of their OMG indicia.

Top Rocker: Motorcycle Club (MC) name –Hells Angels; Outlaws; Bandidos Center

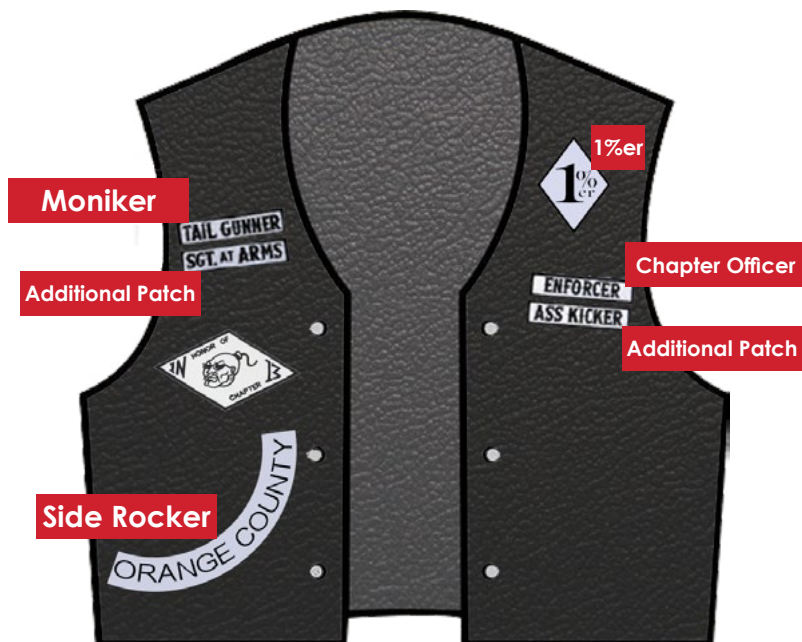
Patch: Club Logo

Bottom Rocker: MC chapter location or territory claimed

SUPPORT CLUBS

(U//LES) Support clubs are smaller MCs that align with a dominant OMG in their area. These support clubs become a force multiplier for the OMG, may aid criminal activities, and are often pools of potential recruits for the OMG. Some support clubs will wear a round patch on their patched vests indicating they are supporting an OMG.

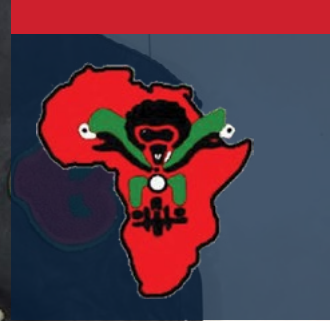

(U//LES) Was established in the early 1960s in New York, New York. The organization also claims to be one of the largest OMGs operating in the State of New York.

CRIMINAL ACTIVITIES

Illegal possession of and/or trafficking of narcotics, illegal possession of firearm(s) and/or ammunition, illegal possession of National Firearms Act (NFA) weapons, weapons trafficking illegal possession of explosives, manufacturing of explosive devices, murder, attempted murder, assault, extortion, threats of violence and intimidation, burglary, trafficking stolen motorcycles and parts, vehicle theft, receiving stolen property, racketeering, conspiracy, and prostitution.



AFRO DOGS

(U//LES) Was founded in the early 1970s in Detroit, Michigan. Shortly thereafter the Afro Dogs opened a chapter in Youngstown, Ohio and the Detroit Chapter became the “Mother Club” chapter. Since its inception, the Afro Dogs have established chapters across the northeastern United States.

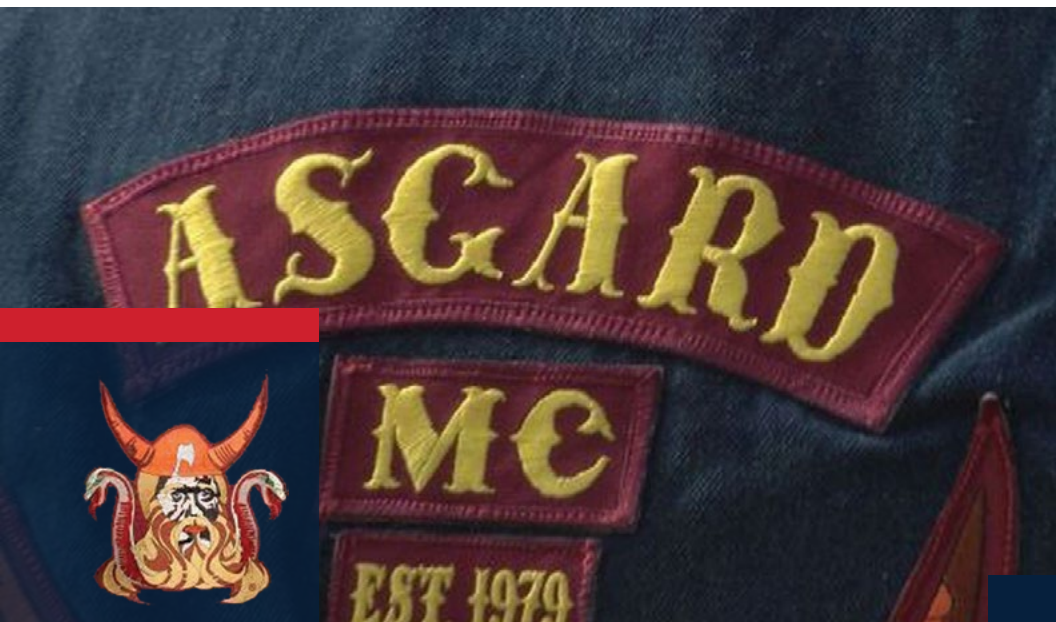

(U//LES) Was founded on 1 January 1979 in Biloxi, Mississippi, with 11 original members. Since then, the club has established several chapters within the State of Mississippi.

CRIMINAL ACTIVITIES

Weapons trafficking, extortion, prostitution, money laundering and illegal possession of and/or trafficking of narcotics.



AVENGERS

(U//LES) Was founded in Waterford, Michigan, in 1967 by Ron Swalwell and has expanded to numerous states across the United States. The Avengers appear to have garnered the respect of other MCs through their refusal to be intimidated or influenced by other OMGs.

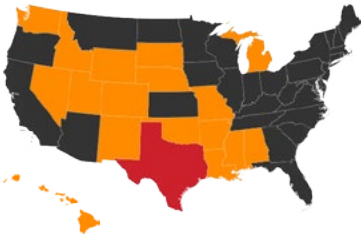

BANDIDOS

(U//LES) Was founded in San Leon, Texas, in 1965 by Donald Chambers. Chambers served as president from 1966 to 1973 when he was convicted of murder and sentenced to life imprisonment. Since 1966, the Bandidos have expanded throughout Texas, the Southwest United States and parts of the Northwest. The first international chapter was established in Australia in 1983 when a faction of the Comancheros MC patched over to become the first foreign chapter of the Bandidos. Today, the Bandidos have chapters throughout Europe, Southeast Asia, Australia, New Zealand, and Central and South America.

CRIMINAL ACTIVITIES

Murder, attempted murder, malicious wounding, threats of violence, weapons trafficking, illegal possession of firearm(s) and/or ammunition, illegal possession and trafficking of prescription drugs, illegal possession of and/or trafficking of narcotics, assault, extortion, intimidation, prostitution, money laundering, conspiracy, racketeering, and arson.



BLACK PISTONS

(U//LES) is the official support club for the Outlaws MC. Established in 2002 with the backing of the Outlaws, the Black Pistons have expanded rapidly throughout the United States, Canada and Europe. The Outlaws use the Black Pistons members as a recruitment source for prospective Outlaws MC members, as well as a force multiplier to increase the Outlaws presence as needed.

BROTHERHOOD

(U//LES) Was founded/established January 1975. The organization claims to be a group of like-minded individuals who have bonded together to live life on their own terms.

CRIMINAL ACTIVITIES

Assault, illegal possession of firearm(s) and/or ammunition, burglary, illegal possession of and/or trafficking of narcotics, theft, intimidation, and thefts of violence.



CHING-A-LING

(U//LES) Was founded in the early 1960s in New York, New York. Originally, the organization began as a local street gang, which later restructured into a motorcycle club. In the beginning, members of the organization consisted of African American and Puerto Rican males. However, it is believed that the group will now accept individuals of other racial backgrounds. Members of the organization, law enforcement personnel, and some motorcycle clubs consider the Ching-a-Lings an OMG.

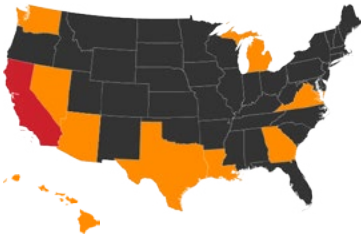

CHOSEN FEW

(U//LES) Was founded in 1959, in Los Angeles, California, by several black males and one black female. The Chosen Few is one of the oldest known predominately black or African American motorcycle clubs in the United States. In 1960, the Chosen Few initiated and accepted its first Caucasian member. Since the acceptance of this first Caucasian member, individuals of various ethnicities and racial backgrounds have been initiated into the organization. Individuals associated with the Chosen Few view themselves as one the first multiracial MC in the United States. The Chosen Few also have a chapter in the Philippines.

Illegal possession of and/or trafficking of narcotics, illegal possession of firearm(s) and/or ammunition, weapons trafficking, illegal manufacturing of narcotics, malicious wounding, assault, murder, attempted murder, arson, intimidation, theft, and trafficking in stolen motorcycles and parts.



COSSACKS

(U//LES) Was founded in 1969 in Tyler, Texas. Historical information indicates that at the time of formation, there were six original members. Since its inception, the Cossacks has expanded to several locations within Texas.

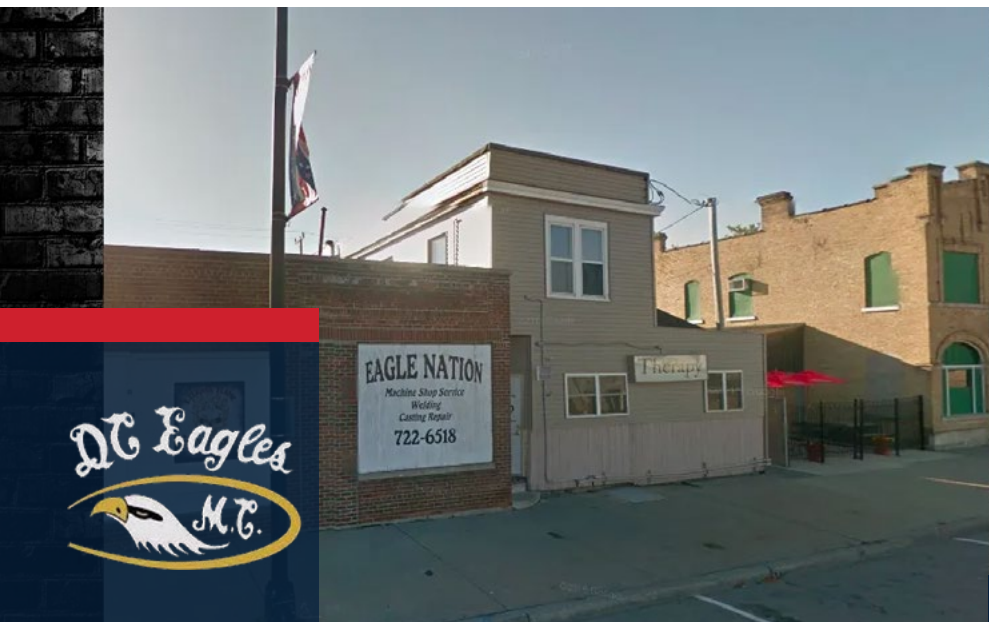

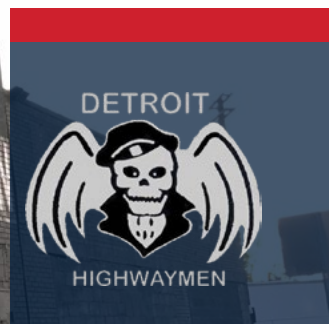

DC EAGLES

(U//LES) Was founded in 1963, in Chicago, Illinois. The organization's motto is Love, Honor, Respect, and complete Trust in your brother. The DC Eagles are an OMG, however, its members do not wear a 1% patch. Instead, members wear a 99% NFG (No Fucking Good) patch. To DC Eagles MC members, the 99% NFG patch has the same relevance or meaning as the 1% patch.

DETROIT HIGHWAYMEN

(U//LES) Was established in 1954, in Detroit, Michigan. Since the inception of the organization, the Highwaymen have spread to numerous areas throughout the central and southern United States.

DEVILS DISCIPLES

(U//LES) Were founded in Fontana, California, in 1967. The club originally consisted of 12 original members, with the word Disciples intentionally misspelled. Since its inception, club members deemed the group an OMG.

Illegal possession of and/or trafficking of narcotics, gambling, arson, murder, assault, extortion, prostitution, threats of violence, illegal possession and trafficking of explosives and firearms, trafficking in stolen motorcycles and parts, theft, conspiracy, and racketeering.



DIABLOS

(U//LES) John Baltas, a motorcycle enthusiast, formed the Diablos MC in San Bernardino, California, in the 1960s. In 1973 Baltas moved the headquarters of the club to Meriden, Connecticut, where the MC remains.

EAST BAY DRAGONS

(U//LES) Was founded in Oakland, California, by Tobie G. Livingston. Originally the Dragons were formed as a car club, however; in 1959, the organization switched over and became one of the first African American motorcycle clubs.

FUGARWE TRIBE

(U//LES) Was founded in Chicago, Illinois, in 1948. Originally, the organization was known as the Road Kings MC. However, in 1955 the club officially changed their name to the Fugarwe Tribe.

GALLOPING GOOSE

(U//LES) The name “Galloping Goose” came from the name given to Dick Hershberg’s motorcycle. Hershberg had the image of the running “middle finger” painted on his motorcycle gas tank. Hershberg and his associates were known to get together for weekend motorcycle runs and were referred to by others as “Galloping Goose” or GG Bunch. In 1949 or 1950 the group officially became the Galloping Goose MC and had 13 original members.

GRIM REAPERS

(U//LES) Was founded in Louisville, Kentucky, in the late 1950s or early 1960s. When formed, the founders of the organization considered the Grim Reapers an OMG from the beginning.

GYPSY JOKERS

(U//LES) Was formed in San Francisco, California, in 1956, and at one time were one of the most powerful motorcycle gangs in California. However, in 1967, the Gypsy Jokers were forced out of California by the Hells Angels MC. The Gypsy Jokers relocated to Oregon.

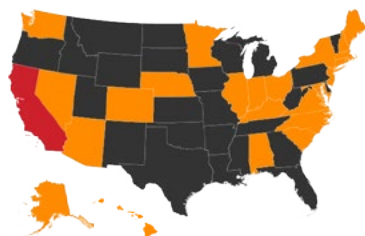

HELLS ANGELS

(U//LES) Was formed in Fontana, California, in 1948. Historical information suggests that some of the original members of the organization were former members of the Pissed Off Bastards of Bloomington (POBOB) MC. In 1957, the “Mother Club” for the Hells Angels was established in Oakland, California. Today, the Hells Angels are one of the largest MCs in the United States and worldwide, with chapters in Africa, Australia, Europe, New Zealand, South America, and Southeast Asia.

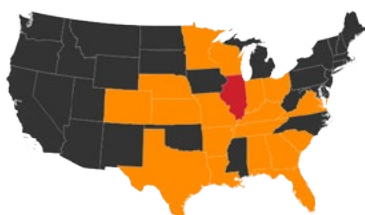

HELL'S LOVERS

(U//LES) Was founded in 1967, in Chicago, Illinois, by two longtime friends and avid motorcycle riders. Early members of the Hell's Lovers viewed the club as one of the first racially-integrated MCs in the country. This ideology contrasted with the non-race mixing philosophy that was prevalent among many white MCs; thus, early Hell's Lovers members considered themselves as the true "outlaws" of the motorcycle club world because they accepted individuals of all racial backgrounds.

(U//LES) Originated in southern California, in March 1968. Since its inception the Hessians have spread to several other locations throughout California.

INVADERS

(U//LES) Was founded in 1965 in Gary, Indiana. The purpose of the organization was to start a nationwide brotherhood of hardcore bikers dedicated to having fun and showing class. From the beginning the founders decided that the organization would be an outlaw-type band of brothers.

IRON HORSEMEN

(U//LES) Originated in Cincinnati, Ohio, in the mid 1960s. Gerald “Round” Hendricks was one of the original seven members and the club’s first president. The Iron Horsemen emulated other OMGs, like the Hells Angels, Pagan’s and Outlaws, quickly adopting their criminal lifestyle.

(U//LES) The founding members of the James Gang MC were originally a sub-group of members of the Diablos MC. These sub-group members were enforcers who “took care of business” for the Diablos. Around 1989, after an internal dispute between the Diablos and their enforcer sub-group, the sub-group left and established the James Gang MC.

CRIMINAL ACTIVITIES

Assault, threats of violence, intimidation, malicious wounding, arson, attempted murder, murder, illegal possession of and/or trafficking of narcotics, and illegal possession of firearm(s) and/or ammunition.



MONGOLS

(U//LES) Was formed in Montebello, California, in December 1969 by several Caucasian motorcyclists. Membership has increased through the recruitment of male Hispanic bikers and transformed the organization into a primarily Hispanic biker gang. Mongols have been known to recruit recently released inmates and street gang members. Internationally, the Mongols have expanded into Europe, Southeast Asia, Canada, Australia, Mexico, and Brazil.

OUTCAST

(U//LES) Was founded in November 1969, in Detroit, Michigan, by four African American motorcycle enthusiasts. These four members proclaimed the organization as a Black 1% MC and offered membership only to Black male motorcycle riders. Members were also required to own a motorcycle that is 90 percent black in color.

OUTLAWS

aka AMERICAN OUTLAWS ASSOCIATION

(U//LES) Formed in 1935, the Outlaws were originally known as the McCook Outlaws MC. In the late 1940s, McCook Outlaws requested charter from the Hells Angels, which was ignored; thus creating animosity between the clubs. Subsequently the McCook Outlaws moved their headquarters to Chicago, Illinois, and the club officially changed its name to the American Outlaws Association (AOA). Internationally, Outlaws chapters can be found throughout Europe, Russia, Southeast Asia, Australia and Canada.

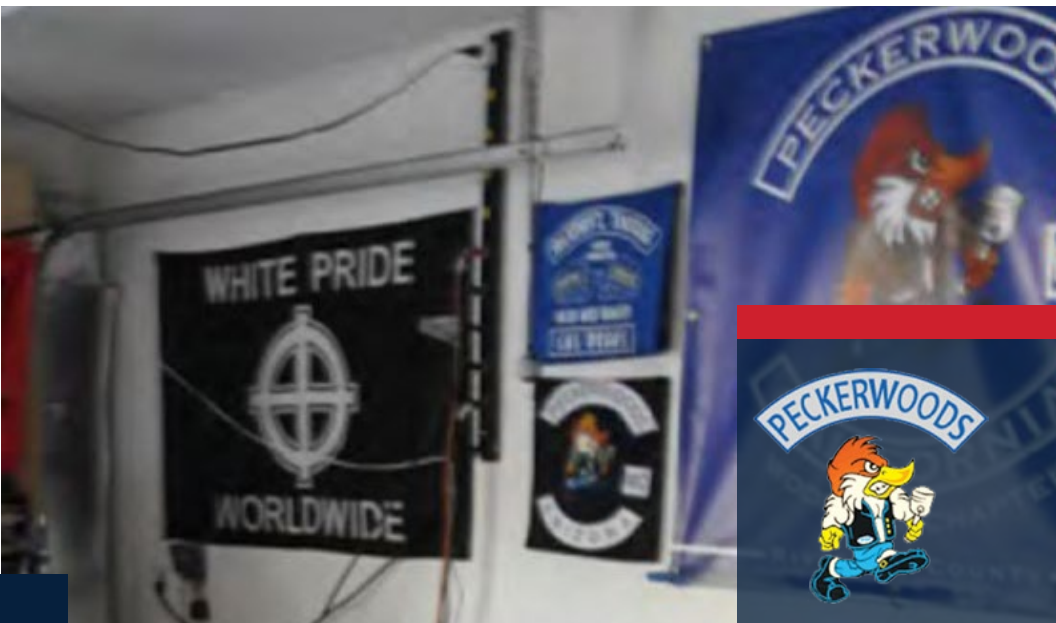

(U//LES) In 1959 Lou Dobkins, a biochemist at National Institute of Health, formed the Pagan's MC in Prince George's County, Maryland. Dobkins and original members began to emulate the 1% philosophy. The club began to establish chapters in other states, and eventually established ties to organized crime groups along the East Coast of the United States.

The Peckerwoods MC asserts that the organization itself is not racist, but they will not be held responsible for actions of individuals who are racist and utilize the name Peckerwood.

The Phantom MC utilizes many of the same color schemes (black, red, and gold) and symbols (cane, white gloves, and the top hat), associated with the Vice Lords street gang. Many Phantom MC members are believed to have affiliations with various street gangs, to include the Vice Lords, Almighty Latin Kings, and various sets of the Bloods.

PHANTOM'S

(U//LES) According to open source information, the Phantom's MC was founded in the late 1950s. Originally the club began as the Phantom's Car Club, however, in 1962, Phantom's members voted to change the organization into a MC. The Phantom's openly proclaim they are an OMG.

PISSED OFF BASTARDS OF BLOOMINGTON

(U//LES) Was founded in 1945 in Bloomington, California, by several World War II veterans and Otto Friedli. In July 1947, POBOB and several other motorcycle clubs were involved in a violent incident occurring in Hollister, California. During the incident motorcyclists took over the town resulting in California law enforcement deeming that some of the participants were “Rebels” or “Outlaws.”

REBELS

(U//LES) Was formed in Brisbane, Australia in 1969. Since then, the Rebels have grown to approximately 150 chapters worldwide; with most chapters in Australia and the United States, but also Europe, South America, Southeast Asia, and New Zealand. In 2012, the Rebels officially established chapters in the United States. Prior to 2012, limited law enforcement reporting suggests that the Rebels may have been operating on a limited and discrete basis in the United States.

RED DEVILS

(U//LES) In 2001 the Red Devils MC became an official support club for the Hells Angels MC. Law enforcement intelligence suggests the Hells Angels formed the Red Devils as a support club for the recruitment of prospective members as well as a force multiplier. In some instances, the Hells Angels forced smaller motorcycle clubs to become Red Devils.

Sin City Deciples also accept individuals with previous street gang or military affiliation.

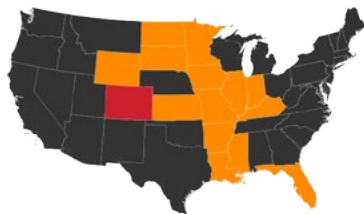

Richardson chose the SOS logo to be an American eagle, sitting on a large letter A which resembles the Anheuser Busch Budweiser beer logo. SOS members state the eagle represents freedom - freedom to ride - while the A stands for America. SOS’s motto is “donec mors non separat” or “until death separates us.” The SOS also have chapters in Germany.

In 2011, Katona was arrested by law enforcement officers for suspected criminal drug trafficking charges. At the time of his arrest, Katona was identified by law enforcement as the Pagan’s Motorcycle Club National President. Shortly thereafter his arrest and subsequent trial, Katona along with several former Pagan’s MC members defected from the Pagan’s and formed the Sutars Soldiers motorcycle club.

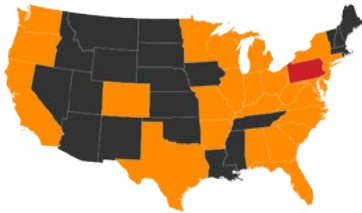
